As per the MP 0142/20 Healthy Options WA Food and Nutrition Policy vending machines are assessed as an individual outlet.

Food vending machine

At least 50% of all food and drinks offered and displayed must be Green

Green items are to be placed at the top or middle sections of the vending machine i.e. eye-level

The remainder of food offered or displayed may be Amber

No more than 20% of food offered can be Red. No more than 20% of all items on display can be Red

Red drinks are not permitted for sale in any retail outlets or vending machines

The remainder of items offered or displayed may be Amber

*No more than 25% of all drinks offered and displayed may be intensely sweetened drinks

No more than 20% of food offered can be Red. No more than 20% of all items on display can be Red

Red drinks are not permitted for sale in any retail outlets or vending machines
