## COVID-19 vaccine transition to National Immunisation Program (NIP)

From 1 October 2026, COVID-19 vaccination in Australia will transition from the current [National COVID-19 Vaccination Program \(NCVP\)](#) to ongoing delivery under the National Immunisation Program (NIP). This transition will support the long-term sustainable approach for managing COVID-19 in Australia, focused on protecting the community against severe illness for those at highest risk.

NIP eligibility may differ from the current eligibility. Anyone who is not eligible for a free COVID-19 vaccine under the NIP will be able to purchase one through the private market.

### Information for immunisation providers:

To ensure that you have sufficient supplies ahead of the transition to the NIP, allocations for Pfizer (LP.8.1) 12 years+ (pre-filled syringe (PFS)) will increase to 1,000 doses from 25 July 2026.

Before the transition, final ordering through Commonwealth processes for the NCVP will close on 28 August 2026. It is important that all orders are placed before this date as no orders will be processed after this date, including orders requested through the Additional Order process. After transition to the NIP on 1 October 2026, ordering will be recommenced via the usual WA state vaccine ordering process.

More information will be provided as it becomes available, including updated eligibility for the NIP funded vaccination.

# Needle anxiety resources

“Needle Anxiety” refers to an overwhelming fear of medical procedures involving needles or injections, which can manifest in both psychological and physical symptoms, including avoidance behaviour and significant distress. Minimising pain during vaccination can help to prevent the distress that manifests from needle anxiety, the development of needle fears and subsequent health care avoidance. Positive experiences during vaccination helps to maintain and promote trust in health care providers.

There is an effective vaccine to prevent and manage chronic hepatitis B. See [immunisation schedule and catch-up vaccines](#) and the [Australian Immunisation Handbook \(AIH\)](#) for more information on doses, timing and contradictions. Though hepatitis C is not vaccine preventable, it is curable.

WA Health's '[Look after your blood](#)' campaign aims to raise awareness of blood borne virus (BBV) prevention and testing among Aboriginal people, with a specific focus on HIV, hepatitis B and C.

For those living with or affected by hepatitis B, the [Hep B Hub WA](#) is a state-wide service provided by Royal Perth Hospital. The clinic offers community health professionals that coordinate care, and offer diagnosis, monitoring, treatment, support and education from general practitioners (GPs) and Nurse Practitioners (NPs) for chronic hepatitis B. This empowers community clinicians and assists in reduction of specialist referrals.
